In the non-performing loans sale conducted on December 23rd, 2024 by Fibabanka A.Ş., our company successfully secured the tender by submitting the highest bid for a SME/ Commercial portfolio with a total principal amount of 430.5 million TL put up for sale. 14 asset management companies joined the tender process.

It is important to note that the finalization of the tender results is subject to the approval of the Board of Directors of the bank.
